**Subject: Online course for Teachers on Action Research through DIKSHA**

Teachers constantly improvise, innovate and redesign their classroom transactions as per the needs of learners on a day to day basis. To record these processes in the form of a systematic research document and to guide our teachers to overcome academic problems they face in the classrooms, CBSE is launching an online course on Action Research which is developed by NCERT. Action research is an interactive inquiry process that balances problem-solving actions implemented in a collaborative context with data-driven collaborative analysis or research to understand underlying causes enabling future predictions about personal and organizational change. Teachers and Principals can join this course through DIKSHA.
