Subject: Principals' / Teachers' Consultation for CBSE Learning Standards Frameworks of Classes IX-X

The National Education Policy (NEP) 2020 has given a clear mandate for competency-based education in order to enhance acquisition of critical abilities of learners, and to make learning experiential. The first determinant for implementing this is a curriculum that is aligned to defined learning outcomes and clearly states the competencies to be achieved. The CBSE in collaboration with Azim Premji University, Bengaluru, over the last year, has developed the 'Learning Standards Framework' for Science, Mathematics, Social Science, English and Hindi for classes IX-X.

The **Learning Standards Frameworks** would be a critical resource for the teacher as he/ she transacts the curriculum. These present standards or competencies that are aligned to the curriculum content and the NCERT Learning Outcomes. They have been developed to ensure the teacher aligns the teaching learning to meet the set quality standards as well as to help to track the learning level of students.

The CBSE desires to orient practicing teachers to these Frameworks and also collect their feedback so that these may be improved and later utilized by schools and teachers. Therefore, the Board is organising a series of consultation programmes with the help of Civic Innovative Foundation (Civis) for educators of classes IX-X across all CBSE schools. The intended objectives of these consultations are to-

- disseminate the Learning Standard Frameworks (classes IX-X);
- elaborate the need and the objectives for these frameworks;
- familiarize educators with different aspects of the frameworks;
- collect constructive feedback from educators (Principals, Vice-Principals & Subject teachers), through Civis platform and;
- address the queries educators may have on the Frameworks.

This program would be organized as a series of online webinar encompassing one webinar session per subject. The sessions would be addressed by the Chairperson CBSE, Director (Academics), CBSE and other CBSE functionaries along with subject experts.

We request you to nominate 02 Senior functionaries (principal/ vice principal/ coordinator/ curriculum designer) and 5 subject teachers, one for each subject of Science, English, Hindi, Mathematics, and Social Science, from your school to attend the webinars and further
