The subject was introduced with the aim of skilling students on the possibilities of emerging technologies while educating them on AI tech and social skills. CBSE in partnership with Intel India, has been regularly conducting AI Capacity Building Programs (CBPs) for teachers and AI Bootcamps for students.

In continuation with the momentum of enabling more schools to opt for AI Skilling for their students and encouraging schools to extend their outreach for skilling more students and teachers on Artificial Intelligence, a monthly orientation session shall be organized for Principals/ Heads of Institutions.
